4. Multiple Measures of predicting Student Success

WHEREAS NATIONAL EDUCATION LEADERSHIP IS SEEKING BETTER PREDICTORS OF STUDENT SUCCESS AND APPROPRIATE PLACEMENT IN COLLEGES AND UNIVERSITIES, MULTIPLE MEASURES ARE BECOMING RECOGNIZED AS PROVIDING MORE APPROPRIATE INFORMATION RELEVANT TO SUCCESS IN HIGHER EDUCATION, AND

WHEREAS NASSAU COMMUNITY COLLEGE HAS UTILIZED SAT CUT-OFF SCORES AS A MEANS OF EXEMPTING STUDENTS FROM TAKING THE NCC PLACEMENT EXAMS, AND

WHEREAS THE SAT CUT-OFF SCORES THAT HAVE BEEN UTILIZED BY NCC TO EXEMPT STUDENTS FROM TAKING THE PLACEMENT EXAMS ARE SIGNIFICANTLY HIGHER THAN THOSE OF AREA COLLEGES AND UNIVERSITIES OR OTHER SUNY COMMUNITY COLLEGES, AND

WHEREAS SAT SCORES ARE NO LONGER WIDELY USED AS THE SINGLE INDICATOR OF A STUDENT'S POTENTIAL, IT IS NECESSARY TO RECONSIDER HOW TO EVALUATE INCOMING STUDENTS WITH RESPECT TO SAT SCORES AS WELL AS OTHER MEASURES OF EVALUATION, AND

WHEREAS COLLEGES AND UNIVERSITIES ARE NOW CONSIDERING MULTIPLE MEASURES TO PREDICT STUDENT SUCCESS, WHICH MAY INCLUDE A COMBINATION OF SAT SCORES, HIGH SCHOOL GRADE POINT AVERAGES, THE DIFFICULTY OF COURSES ATTEMPTED IN HIGH SCHOOL, SUCH AS ADVANCED PLACEMENT COURSES OR ADVANCED MATH OR SCIENCE COURSES, AND GRADES ON RELEVANT STATEWIDE EXAMS, SUCH AS THE NEW YORK STATE REGENTS EXAMS, AND

WHEREAS IT IS IN THE INTERESTS OF THE STUDENTS OF NCC TO HAVE THE BENEFIT OF IMPROVED PREDICTORS OF STUDENT SUCCESS,

**BE IT RESOLVED** THAT THE BOARD OF TRUSTEES OF NASSAU COMMUNITY COLLEGE DIRECTS THE DEVELOPMENTAL EDUCATION COMMITTEE OF THE ACADEMIC SENATE TO MAKE RECOMMENDATIONS BY MAY 7, 2015 WITH RESPECT TO THE PROTOCOLS FOR EXEMPTING INCOMING STUDENTS FROM THE NCC PLACEMENT EXAMS THAT REFLECT PREVAILING AREA STANDARDS VIA A SET OF MULTIPLE MEASURES, INCLUDING, BUT NOT LIMITED, TO ACT OR SAT SCORES, HIGH SCHOOL GRADE POINT AVERAGES, THE DIFFICULTY OF COURSES ATTEMPTED IN HIGH SCHOOL, SUCH AS ADVANCED PLACEMENT OR ADVANCED MATH OR SCIENCES COURSES, AND GRADES ON RELEVANT STATEWIDE EXAMS, AND

**BE IT FURTHER RESOLVED** THAT FAILURE OF THE COLLEGE'S GOVERNANCE PROCESS TO IMPLEMENT THIS DIRECTIVE REGARDING DEVELOPING THE PROTOCOLS FOR EXEMPTING INCOMING STUDENTS FROM THE NCC PLACEMENT EXAMS THAT REFLECT PREVAILING AREA STANDARDS WILL RESULT IN THE ACTING EXECUTIVE VICE PRESIDENT AND THE ACADEMIC AREA DEANS ASSUMING THE AUTHORITY TO ASSURE NCC'S DEVELOPMENT OF SUCH PROTOCOLS.
